



## **PLANet User Information and Authorization**

The Public Employees Pension Plan (PEPP) requires employer authorization for all user profiles to be created under their PLANet account. Please have an authorizing individual (supervisor, director, etc.) fill out all applicable fields.

- You must choose a security level for each PLANet user:
  - 1. Payroll and HR Forms this user will have all capabilities (both Payroll and HR)
  - 2. Payroll this user will only have access to remit payroll files
  - 3. HR Forms this user will only have acces to remit HR Form files (i.e. enrolments, date & status changes, leave, termination)
- Submission of the form with electronic signatures is allowed.
- The form **must** be emailed to erc.pepp@plannera.ca from the authorizing individual to comply with pension policy. All other forms will not be accepted.
- If your organization will have more than three PLANet Users, please completely fill out a second form.
